6. Update on the SCR

The Steward of the SCR reported that Ms. Gosia Fitzgerald had been appointed as Front of House Manager following Mr. Webber's retirement. She noted that the Middle Common Room had been renamed the Webber Room in his honour and thanked Mrs. Diment for co-ordinating the leaving events.

7. Presentation by the Masterplan consultants

The Principal Bursar updated Governing Body on the Masterplan. The refurbishment of the Thomas White Building was progressing to RIBA Stage 3 design and the proposed new energy centre to RIBA Stage 2.

The principles for other projects [] were still being discussed and scrutinised. The Principal Bursar thanked the Working Party for their input on the plan. It was enivsaged that the next steps would be presented to Governing Body in Week 9.

The consultants on the Masterplan presented the background to the overall proposals, including the site evaluations that had been undertaken and consultations with staff and students. Carbon conservation was a key challenge, given the age of many of the College's buildings and their listed status.

Consideration had been given to a number of possible sites for the proposed energy centre with the preferred solution offering an opportunity to use the ground floor of the building for social and communal spaces, including the College Bar.

Plans for the Thomas White Building project were based on a number of key principles, including decarbonization, wellbeing and inclusivity, and connectivity.
