1. Minutes and matters arising

The minutes of the meeting of Governing Body held on 4th October were **approved**.

2. <u>Educational Policy Committee</u>

The minutes of the meeting held on 18th October 2023 were received.

The Governing Body **agreed** that the Junior Research Fellowships of Dr. Boronski, Dr. He and Dr. Flannigan should be extended for a fourth and final period of one year, with effect from 1st October 2024.

Professor Obloj reported on the proposal to establish means-tested scholarships for undergraduate students from overseas who were not eligible for funding via the REACH Scholarship scheme. The Governing Body **agreed** that, subject to the establishment of an appropriate memorandum of understanding between the donor and the College, an undergraduate scholarship in Mathematics should be created, to be offered to one student for a period of three or four years []. The scholarship would serve as a pilot for future scholarships in a range of subjects to fund international students. It was noted that donor screening had been completed in advance of presentation of the paper.

Sabbatical leave was agreed for Professor Maini in Michaelmas Term 2023 and for Professor Omri in Michaelmas Term 2023 (after postponement of the leave previously approved for this term).

It was also **agreed** to elect Bulscú Diossi, William Hartridge, Edward Huang, Haru Ishikaza, Judy Li, Athary Mahajan, Katinka Mitchell-Thomson, Alice Simmerson Saxon Stacey, Luke Storey, Sol Woodroffe, and Zhi-Xuan Koh to Casberd Scholarships.

3. Promotion of the Arts Committee

This was very timely as the portrait would be shown in a National Portrait Gallery exhibition in summer 2024.
