PRINCIPAL BURSAR

6. Educational Policy Committee

The minutes of the meeting held on 21st November were received.

The committee's recommendation concerning Tutorial Fellows and teaching buyouts was **approved**, subject to the modification that the scheme would "normally only be available to Tutorial Fellows, for commencement no more than five years after the confirmation of appointment to the retirement age".

SENIOR TUTOR

The recommendation that the college should bid for an association with a University Lectureship in Old Testament Studies, to be associated with an Official Fellowship and Tutorship in Theology and Religion, was discussed. The discussion covered the recent changes in the teaching of Theology and Religion, the popularity of Religious Studies A-level and that of Theology at degree-level, the college's current arrangements for teaching in Theology and joint schools, the numbers of students in small subjects and the breadth of subjects taught in college. After a vote the recommendation was **approved**.

SENIOR TUTOR

It was **agreed** that the post of Schools Liaison Officer should become an established post within the administration of the college.
