1. Minutes

7. Staff Pay

The Principal Bursar reported on the recent staff pay settlement. A general increase of 3% has been agreed for all staff paid on College scales. It was noted that this exceeds the increase in the national minimum wage (2.5%) and also that, given the College's employee pension contribution rate of 6.035%, the equivalent rates of pay meet the level set by the Oxford Living Wage Campaign.

8. JCR President

On behalf of the Governing Body, the President thanked the outgoing JCR President and JCR Committee for their work and co-operation over the past year. The outgoing JCR President, David Messling, thanked the Governing Body for taking an inclusive approach to decision-making on issues relevant to the student body. The President extended the Governing Body's welcome to the new JCR President, Uchechukwu Ukachi, and his Committee.
