1. Minutes of Governing Body and matters arising

The minutes of the meeting of Governing Body held on 22<sup>nd</sup> January 2025 were **approved**.

2. General Purposes Committee

The minutes of the meeting held on 5<sup>th</sup> February 2025 were received.

The Governing Body elected Professor Wright as Vice-President until 31<sup>st</sup> August 2025.

The Provost for Academic Affairs explained that the review process for Professor Jones's initial period of office was out of sync with the University's procedures and the College Statutes since he had started during the Covid crisis. It was **agreed** to renew Professor Jones's Fellowship for a period of one year from 1<sup>st</sup> October 2025.

It was **agreed** to renew Professor McDowell's Emeritus Research Fellowship for a fourth threeyear period from 1<sup>st</sup> October 2025

It was also **agreed** to renew Professor Bray and Professor Snowling's Emeritus Research Fellowships for a second three-year period from 1<sup>st</sup> October 2025.

The Vice-President reported on the nominations for Honorary Fellowship. It was **agreed** that two candidates would be invited to accept an Honorary Fellowship from the College.
