1. Appeal against Governing Body decision

The President reported that Professor Weidberg had notified her on 18th January 2025 that he wished to appeal the decision of Governing Body made on 4th December 2024, following the report of the College EJRA Panel.

Professor Weidberg was served notice of the decision on 6th January 2025 with twenty-eight days to make his appeal.

The President reminded Governing Body that it had decided that Professor Weidberg's Official Fellowship would not be extended past his EJRA and that the College wished to retain its association with the joint appointment with Physics. Governing Body had also agreed not to extend Professor Weidberg's EJRA to a 0.3FTE teaching post.

The President noted the appeal procedure and that, under the terms of By-Law XLI (8), the Governing Body needed to appoint a person as chair to hear the appeal.

After discussion, it was **agreed** to ask [] if she would be willing to serve as chair of the Appeal Panel.

The President would keep Governing Body informed of progress in the appeal.
