1. Minutes and matters arising

The minutes of the meeting of Governing Body held on 7th March 2018 were **approved**.

The President welcomed Mr. Crow, Director of Development and Alumni Relations.

2. Domestic Committee

The minutes of the meeting held on 2nd May 2018 were received.

The Governing Body **agreed** that at any occasion where guests were allowed in Hall, SCR (if on low table), MCR and JCR members seated at low table might bring guests of any age or other personal characteristic, provided the College's Safeguarding Policy was followed. This included lunch, informal dinner and regular formal dinner, with the usual requirement that members planning to bring a guest must inform the organisers in advance to ensure adequate seat availability. Normal rules in terms of disruptive behaviour would apply, which might result in the removal of the member as well as their guest. Take-up would be monitored and the policy reviewed at Domestic Committee in Michaelmas Term.

3. Educational Policy Committee

The minutes of the meeting held on 2nd May 2018 were received.

The Senior Tutor noted that the deadline for receipt of application for the Academic Grant would be changed to Friday of 9th Week in Hilary Term of each year to enable final-year undergraduates to claim the cost of thesis binding.

He also highlighted the 2018 Academic Feedback Thematic Report. It was noted that students in some subjects did not participate and that it would be useful to review how feedback was gathered.
