# 1. Minutes and matters arising

The minutes of the meeting of Governing Body held on 25<sup>th</sup> June 2019 were **approved**.

In matters arising the Finance Bursar reported on consultation documentation received between 30<sup>th</sup> June and 4<sup>th</sup> July 2019 regarding USS, including legal advice to the College. It was **agreed** to send a response to UUK's consultation and subsequent information, and to request further information in order to inform the Governing Body's decision-making.

The President noted that the student being supported by the Higby Trust would transfer fully from Mansfield College to St John's.

## 2. College Contribution Scheme

The President noted that Conference had asked that the paper for Council on the College Contribution Scheme proposal should make it clear that the separate enquiry into the position of poorer colleges and PPHs would not consider any further transfers of funds between Funding colleges and others during the life of the proposed Scheme 7.

### 3. EJRA

Professor Armstrong's request to work beyond his EJRA had been granted for eighteen months until 31<sup>st</sup> March 2021. The Governing Body **agreed** that he would be permitted to make a further application to extend his employment beyond the period already approved, if he wished.

It was also **agreed** that the President would write to Professor Pitcher to clarify his status from 1<sup>st</sup> October 2019.

## 8. Promotion of the Arts Committee

## 15. President's report

The President noted with sadness the recent loss of George Richardson, Honorary Fellow.

She highlighted Fellows' achievements over the year, the appointment of the College's first professional Senior Tutor and the admission of the Director of Development and Alumni Relations to Governing Body.

She noted the initiatives that were helping the College to broaden its diversity: the project on the College's colonial past, the first Black History lecture, the plans for celebrating the 40 years of women and the new Pre-GCSE Inspire Programme. She particularly thanked the Fellow for Access and Admissions and Ms Cripps for their work on the latter and for securing the substantial donation that had made it possible. She also noted the work on refurbishing Dolphin Quad, the launch of the intranet and progress on College communications. She thanked the staff involved and the staff across College who had covered roles during the year.

The President thanked demitting College Officers, and especially the Vice President (Domus), Domestic and Establishment Bursar, Fellow for Graduates, Fellow Librarian and Keeper of the Vestments, and the Prevent Co-ordinator for their hard work and support. She especially thanked Professors Whittaker and Grafen for their service to the SCR over many years.

## 16. Any other business

The Governing Body **agreed** to set up a subsidiary trading company for the College's non-charitable trading activity (primarily commercial events/conferences for non-education institutions) in line with Charity Commission advice and sector best practice.
